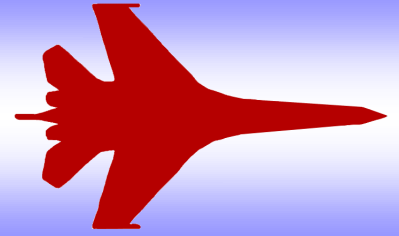

President's Comments

A motion was made to amend the TRAC Constitution to define a member category for those who spend part of their time in the Tampa area, commonly referred to as "Snowbirds". After two months of discussion on this, a vote to pass this motion will be taken at the March 2022 meeting. The motion wording is below, with the changes in italics.

Article 7, Section 5 will be amended as follows:

Section 5. Annual membership dues for Youth members (members not attaining the age of 19 as of July 1) will be \$50.00 with the Initiation Fee waived.

Annual membership dues for Family Membership (members who reside in the same household) will be 1.5 times the single adult membership fee.

Annual Membership dues for a Seasonal Member will be ½ the current annual membership dues.

A Seasonal Member is defined as an individual whose primary residence is outside of Florida, and who resides in Florida on an occasional basis, not to exceed 6 months in a calendar year. A Seasonal Member will have all of the rights of a Regular Member with the exception of voting and holding office.

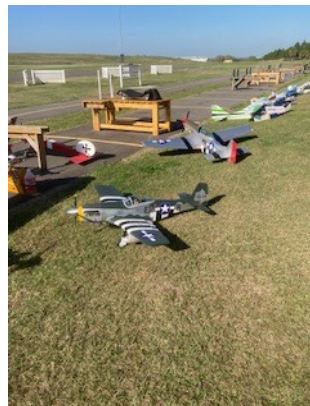
